§ 1. THE ADMINISTRATOR OF PERSONAL DATA HOTEL GUESTS

§ 3. OBJECTIVES OF THE PROCESSING OF PERSONAL DATA HOTEL GUESTS

The purpose for which personal data is processed Hotel is the conclusion and implementation of contracts for the provision of hotel services. Moreover, the purpose of data processing

The hotel is personal:

1. investigation of possible claims by the hotel in connection with the hotel suffered damage caused by a will or to defend against claims will be compared to the Hotel,
2. documenting the service for tax purposes,
3. providing the highest quality service to hotel guests.

If the Guest has consented to the processing of personal data for marketing purposes, Hotel processes personal data for this purpose, ie. For will drive the marketing information and offers about their products and services. In addition, hotel guests processes personal data collected by Monitoring the hotel in order to ensure the safety of hotel guests and other persons in the hotel premises.

§ 4. LEGAL BASIS THE PROCESSING OF PERSONAL DATA

1. The legal basis for the processing of personal data will be procured by the hotel is a contract for the provision of hotel services.
2. The legal basis for the processing of personal data will be used for marketing purposes is consensus will. The hotel informs that consent may be withdrawn at any time. The withdrawal of consent does not affect the validity of the process, which took place before withdrawal of consent.
3. The legal basis for the processing of personal data will be the monitoring of the protection of its vital interests and the protection of vital the interests of other individuals, as well as a justified goal administrator.
4. The legal basis for the processing of personal data will ensure the highest quality of services for hotel guests is justified goal administrator.

§ 5. ENTITIES, WHICH MAY BE GIVEN PERSONAL DATA

Hotel transmit personal data to the following categories of persons:

1. companies providing IT support services and the hotel providing computer software,
2. accounting firm providing accounting services,
3. transport companies and taxi businesses in order by the situation will transport or courier,
4. firms (law firms) providing legal advisory services and legal representation.

§ 6. THE PROCESSING OF PERSONAL DATA

Personal data:

1. acquired in connection with the agreement for the provision of hotel services will be processed by the limitation period of tax claims Hotel or civil claims or will be, in whichever occurs later,
2. obtained on the basis of consent for marketing purposes will be processed for the duration of consent for marketing purposes,
3. obtained in connection with the monitoring will be processed by 30 days of fixation, and then will be permanently removed.

§ 7. GUEST'S RIGHTS IN CONNECTION WITH THE PROCESSING OF PERSONAL DATA

Each guest has the right of access to personal data, rectification, erasure or restriction of processing. In addition, every guest has the right to object to the processing. Access to the data is possible in the seat of the hotel. In addition, the hotel provides the address for imprezy@hotelarkadia.pl by which you can be contacted on personal data.

§ 8. POSSIBILITY OF FILING A COMPLAINT WITH REGARD TO THE PROCESSING OF PERSONAL DATA

Each guest has the right to lodge a complaint against the processing of his personal data to the supervisory authority, which is the General Inspector Personal Data Protection, ul. 2 00-193 Warszawa rates.

§ 9. REQUIREMENT OF ADMINISTRATION OF PERSONAL DATA

Provide personal information in terms of name, address, email address, in case of internet bookings, number contact phone, the child's age, in case of stay in a hotel with a child is a requirement of the conclusion of the hotel services. No application data Personal prevent the conclusion of hotel hospitality services.

§10. AUTOMATED DECISIONS BASED ON PERSONAL DATA, INCLUDING PROFILING

The hotel does not make automated decisions based on personal data, including not make profiling.
